Important Notes on Application for the Accredited Geopark Guide Pass

With a view to maintaining the standard of geotours and the international image of Hong Kong Geopark, the Travel Industry Council of Hong Kong (TIC) has established a Geopark Guide Accreditation System since 8 March 2011 to raise the professional standards of geopark guides in Hong Kong. Geopark guides accredited by the TIC are called Accredited Geopark Guides (A2Gs), and the identity document for an A2G is called the Accredited Geopark Guide Pass (A2G Pass).

(I) Application requirements

- 1. Having passed the Qualifying Examination for Accredited Geopark Guides;
- 2. Holders of a <u>valid</u> first aid certificate issued by one of the following six institutions: the Hong Kong Red Cross, the Hong Kong St. John Ambulance Brigade, the Auxiliary Medical Service, the Hong Kong Life Saving Society, the Hong Kong Police Force, and the Hong Kong Fire Services Department; and
- 3. Agreeing to accept and comply with the following rules and regulations:
 - the code for geopark guides as specified on the R2G Secretariat website (http://www.hkr2g.net)
 - regulations issued by the TIC, which are relevant and applicable to the A2Gs

(II) How to apply

- 1. Return the completed "Application Form for the Accredited Geopark Guide Pass" together with the following documents to the TIC by post or in person:
 - i. A **photocopy**** of the result slip of the Qualifying Examination for the Accredited Geopark Guides;
 - ii. A photocopy** of the first aid certificate issued by institutions recognized by the TIC;
 - iii. One 1.5" x 2" recent colour photo on white background with the applicant's name written on the back; and
 - iv. A crossed cheque payable to "Travel Industry Council of Hong Kong". (Cash will be accepted for submission of application in person. Please do not mail cash.)
- 2. For applications submitted by post, an acknowledgement of receipt of the application documents will be sent by SMS or email. Applicants who do not receive any message of acknowledgement within 7 working days since the date of posting may contact the TIC Industry Training Department on 2807-1199.
- 3. Eligible applicants will be issued the Pass within 4 weeks from the date of submission of application. Pass holders will be notified by SMS or email when the Pass is ready for collection. Applicants who do not receive any notification for the collection of Pass in due course may contact the TIC Industry Training Department on 2807-1199.

**Notes: Applicants should bring the original of the supporting documents required for our verification if they submit their application in person. Otherwise, they must produce the original of those documents when they collect their A2G Pass. All the original documents will be returned to the applicants immediately after verification.

(III) Application fee

(IV) Time limit for application

- 1. People who have passed the Qualifying Examination for Accredited Geopark Guides must apply for the A2G Pass within two years since the issue date of the examination result. The Pass is valid for 3 years.
- 2. If qualified applicants apply for the Pass after the time limit, they will have to re-take the designated course and pass the Qualifying Examination for Accredited Geopark Guides before submitting their application.

(V) Important points to note for pass holders

- 1. A2G Pass holders can provide tour guiding services to the inbound visitors only within the HK Geopark.
- 2. Pass holders who wish to receive inbound visitors outside the HK Geopark must hold a valid Tourist Guide Pass issued by the TIC and be assigned by a licensed local travel agent. Otherwise, they may have violated the Travel Agents Ordinance.
- 3. In order to ensure the quality of the geotour guiding services, the A2Gs will be re-assessed <u>every three years</u>. Pass holders must meet both requirements a) and b) listed below, and may be required to attend an interview conducted by the A2G Assessment Board (consisting of at least three members or their representatives, who are from the TIC, AGHK and AFCD) to retain the A2G qualification.
 - 30 hours of continuing education, including training sessions, seminars or visits recognized by the R2G Secretariat.
 - b) 30 hours of geopark guiding experiences as an R2G or A2G, with at least three hours of guiding conducted in a foreign language or Putonghua.

Only continuing education hours and relevant records verified by the R2G Secretariat will be accepted by the TIC. Please refer to the R2G Secretariat website (http://www.hkr2g.net) for further details.

(VII) Notes on collection of personal data

- 1. The personal data provided in the Application Form for A2Gs will be used by the Travel Industry Council of Hong Kong (TIC) for the following purposes:
 - (i) to process applications for the A2G Pass;
 - (ii) to maintain applicants' records in the TIC;
 - (iii) to issue the A2G Pass to qualified applicants;
 - (iv) To display the Chinese and English names of Pass holders, their Pass numbers and the expiry dates of their Passes on the TIC's website, and the Chinese and English names, photo, email addresses and personal profiles of Pass holders on the R2G Secretariat website, which may be accessed by members of the public;
 - (v) to post on the TIC's website the information on suspensions or revocations of A2G Passes, which may be accessed by members of the public;
 - (vi) to disseminate information of the TIC (including course information) to Pass holders by any means (including SMS, email, fax, post, etc.); and
 - (vii) any other related purposes.
- 2. Applicants are advised to provide sufficient information as far as possible, otherwise their applications may be unable to be processed.
- 3. Applicants will be required to produce their HKID Card in person for verification purposes, and staff of the TIC will only sign the application form after verifying the contents of the applicant's HKID Card. If an applicant is unable to come to the TIC in person, the applicant may submit a copy of his/her HKID Card by post or by fax but any such copy shall be retained until such time as the applicant concerned is able to produce his/her HKID Card in person for verification purposes. The TIC reserves the right to require the production and to make and retain copies of an applicant's HKID Card in any circumstances which are permitted by law.
- 4. The TIC will keep the personal data of applicants confidential but may provide such data to any other person or his/her representative for any one or more of the purposes set out in paragraph 1 above.
- 5. According to the Personal Data (Privacy) Ordinance, applicants have the right to:
 - (i) ascertain whether their personal data are held by the TIC;
 - (ii) obtain a copy of the data mentioned in paragraph 5(i); and
 - (iii) correct their personal data held by the TIC.

Applicants should provide the TIC with sufficient information in order for their identity to be determined, otherwise their data access request may be rejected. The TIC may impose a fee on any such request.
