Terms of reference

職責

- To set up an effective and reasonable mechanism to handle cases in which registered shops have breached their pledges.
制訂有效及合理的機制處理登記店鋪違反承諾的事宜。
- To hear cases in which registered shops are suspected of breaching their pledges, and penalize those shops found to have breached their pledges.
處理登記店鋪涉嫌違反承諾的個案及懲處有關店鋪。
- To handle other matters related to shopping.
處理其他購物的事宜。

Composition

組成

- The Committee is composed of trade members, non-trade members and an ex-officio member.
委員會由業界委員、業外委員、一名當然委員組成。
- The Convenor of the Committee must be an Independent Director.
委員會的召集人必須是獨立理事。
- The majority of the members of the committee must be from outside the trade.
委員會必須有過半數的業外委員。

Quorum and frequency of meetings

會議的法定人數及次數

- The quorum for transacting general business of the committee is one half of the members of the committee plus one member present.
委員會處理一般事務的法定人數為委員會人數的一半再加一。
- The quorum for meetings of the panel set up under the Committee for handling cases of suspected breach of pledges is, including the convenor or the deputy convenor of the Committee, five members present. Among those present at a panel meeting, non-trade members must constitute the majority.
委員會轄下設有小組，負責處理涉嫌違諾個案。小組會議的法定人數為五名委員(包括委員會的召集人或副召集人)，出席的委員中必須有過半數的業外委員。
- The meetings are held as deemed appropriate.
委員會根據需要而召開會議。
